<p>1. Chair's opening remarks: CF welcomed everyone to the meeting. CF proposed that Hugh Moffat be a co-opted member of the Community Council; TG seconded.</p>	
<p>2. Apologies: Cllr Tim Brett, Kate Hughes (Locality Manager), Mark Sharp (Treasurer).</p>	
<p>3. Approval of Minutes of 02.0.10 Concessionary travel should read concessionary rail travel. Otherwise minutes were proposed as accurate by CF; seconded by HM</p>	
<p>4. RAF issues: a) <u>Regiment squadron</u>: Forty personnel have arrived. The squadron will be a full strength in August. b) <u>Runway repairs</u>: runway expected to be back to normal mid May. c) <u>Community Centre</u>: still on target. d) <u>National families week</u>: Running from 31.05.10-06.06.10. e) <u>Skate Park</u>: The recycling bins have been removed because of building of the Community Centre – there have been complaints of rubbish lying around. SM to request Kate Hughes arrange for re-siting of bins. f) <u>Sports day for local schools</u>: scheduled for 26.05.10 and 29.09.10. g) <u>Leuchars & Guardbridge primary schools</u>: a visit to the camp to be arranged soon. h) <u>Airshow 2010</u>: scheduled for 11.09.10. Media campaign will start at the beginning of June. i) The Duke of Kent (Hon Air Commodore) visited the base recently.</p>	SM

<p>6. Matters arising from previous minutes: a) <u>Doocot field development</u>: Planning permission to be submitted in two months time. The developers are hoping to start building in 12-18 months time. b) <u>Local and Structure Plans</u>: No further update. c) <u>Exit from Meadow Road</u>: Two Rosebank Park residents complained about the difficulty of exiting and entering Meadow Road, particularly exiting. They presented a letter to the Community Council signed by residents of Rosebank Park and Meadow Road detailing the problems. Following the general discussion about this problem, the other member of the public who lives in Main Street complained of the traffic speeding down Main Street. His car had recently been hit when it was parked outside his house. Heavy traffic keeps hitting a bump in the road and the road has gone down 55mm. The member of the public is very unhappy that the road is not being repaired. He also queried why the slow-down sign has not been installed. It was suggested that maybe a pedestrian crossing could be installed in Main Street to help slow down the traffic. One of the Rosebank Park residents asked why, if the entrance to Meadow Road (which is unadopted) is being dealt with by the Council, the whole of Meadow Road cannot be repaired. Cllr Caird confirmed that there is a fund for unadopted roads which D Smeaton is in charge of. 3. JF reported a very large pothole at the back of he houses in St Bunyan's place on the service road going towards the public toilets. The binmen said they would report this. TG will also report to the person in charge of pothole repairs. 4. JF also reported on the travellers site. The site is nothing like what was submitted in the retrospective planning application the Council, and now has a large number of caravans on it. Cllr Caird will contact John Watson about this. 5. CF asked Cllr Caird if CC members should b issued with name/identity badges. He advised contacting Linda Purdie. 6. CF reported that the primary school now has a second eco flag. 7. CF has requested funding for a laptop and printer/scanner for CC use. 8. CF has written to the Royal Pharmaceutical Society regarding the situation with the dispensary in the Post Office and the potential conflict of interest. 9. Plants for the summer tubs are coming at the end of May. One of the tubs is continually flooding. The Main Street resident said he would drill holes in the tub to stop this. 10.
